S.O. 2537 (E).—In pursuance of the provisions of rule 10 of the Indian Veterinary Council Rules, 1985, made in exercise of the power conferred by clause (g) of sub-section (3) of section 3 of the Indian Veterinary Council Act, 1984 (52 of 1984), the returning officer hereby appoints the following dates for holding election of members from amongst persons enrolled in the Indian Veterinary Practitioners Register of the Veterinary Council of India.

- (b) Date and time for scrutiny of nominations : On Saturday, the 24th October, 2009 at 5.00 p.m. at the office of the Returning officer
- (c) Last date for withdrawal of candidature : On Monday, the 26th October, 2009 at 5.00 p.m. at the office of the Returning Officer
- (d) Date on which a poll, if necessary, shall be taken : On Monday the 30th November, 2009 at 5.00 p.m.
- (e) Date, time and place for counting : On Tuesday, the 1st December, 2009, at 10.00 a.m. onwards and on or before 3rd December, 2009 at Animal Quarantine and Certification Service Station, Department of Animal Husbandry, Dairying and Fisheries, Ministry of Agriculture, Kapashera Crossing, Near Kapashera Police Station, old Delhi-Gurgaon Road, New Delhi - 110037.

The eligible candidates may send their nomination papers in Form-I annexed herewith by registered post acknowledgement due or deliver the same in person to the Returning Officer, Shri G. Subramani, Deputy Secretary, Room No. 230, Krishi Bhavan, New Delhi, on or before the appointed date and time for contesting election to the Veterinary Council of India.
